3.2. Purpose of Data Processing

EasyBase OPS and www.easybaseairsoft.hu are used for the following purposes:

- creation and management of user accounts**
- login and access control (player / admin)**
- event-related functionalities**
- rankings, XP system, statistics**
- security and permission management**
- communication (notifications, newsletters)**

3.3. Scope of Processed Data

During registration:

- full name**
- callsign**
- email address**
- password (stored in encrypted form)**

- **year of birth**
- **acceptance of the Terms and Privacy Policy (timestamp recorded)**

During profile usage:

- **profile picture / avatar (optional)**
- **system usage data (e.g. login timestamps)**
- **game-related statistics (XP, rank, events)**

For marketing purposes:

- **email address**
- **subscription status (newsletter, promotional messages)**

3.4. Legal Basis of Data Processing

Data processing is based on:

- **Performance of a contract (account creation, system usage)**
- **Legal obligation (data security, accountability)**
- **Consent (marketing, newsletters, promotional emails)**

Consent may be withdrawn at any time.

3.5. Data Storage Location and Method

- **data is stored in a Supabase-based database**
- **during testing, certain data may be temporarily stored in localStorage**
- **appropriate technical and organizational measures are applied to protect personal data**

3.6. Data Transfer and Data Processors

The data controller may use:

- **hosting and database service provider (Supabase)**
- **email service provider (notifications, newsletters)**

Data is shared with third parties only to the extent necessary for system operation.

3.7. Data Retention Periods

- **user account data: until account deletion**
- **marketing data: until consent is withdrawn**

- **security and log data: up to 12 months**

3.8. Data of Minors

- **the system may not be used under the age of 14**
- **between 14–16 years: parental supervision required**
- **between 16–18 years: written parental consent required**
The data controller reserves the right to verify eligibility.

3.9. Data Subject Rights

Users have the right to:

- **request information about data processing**
- **access their personal data**
- **request correction of data**
- **request deletion of data**
- **request restriction of processing**
- **object to data processing**
- **lodge a complaint with the supervisory authority**

4.5. Minors

4.5.3. Between the ages of 16–18, written parental consent is required.

4.5.4. The operator reserves the right to verify eligibility.

4.6. User Conduct

4.6.1. The following actions are prohibited:

- unauthorized access**
